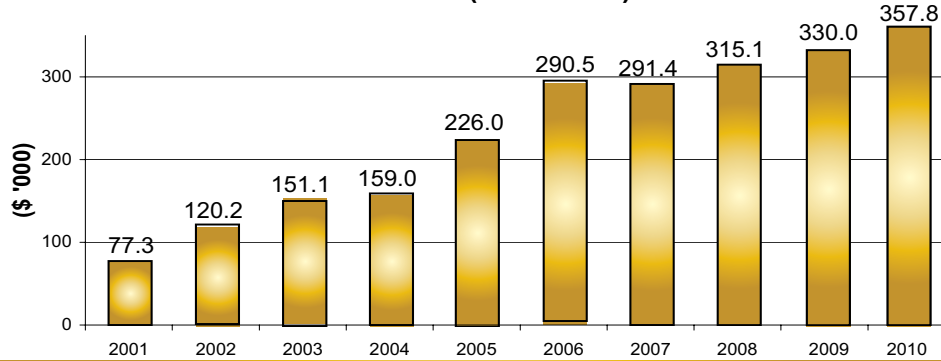

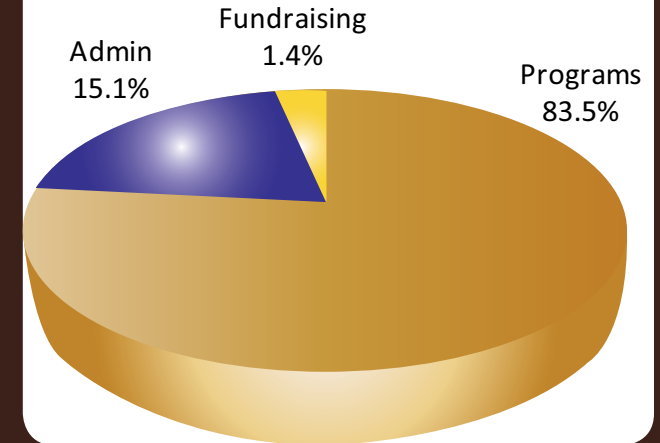

PACIFIC CREST YOUTH PROGRAMS

Drum and Bugle Corps

Arguably our most visible program -- the flagship of Pacific Crest -- is our Drum and Bugle Corps. The corps enrolls 140 performers each year, representing 70 cities and communities throughout Southern California. "Our members are amazing," explains Stuart Pompel.

"Their passion for performance, combined with a persevering work ethic, creates an incredibly dynamic and exciting environment." Indeed, the corps has grown from a weekend-only locally-performing group to a World Class nationally-touring ensemble. Of course many will remember that the corps' original



philosophy did not support a touring model. "Our members began telling us, however, that they wanted to tour," says Pompel. "I have to say that the tour allows for an impressive maturation and development of these young people. If maturation is a forced condition, tour is the laboratory for creating that condition!"

Educational Clinics

Only three years after the creation of Pacific Crest, our instructional staff felt that merely auditioning students was not enough. It was decided that a three-day Fall Workshop Program be developed with master classes, rehearsals, and capstone performance. The program now takes place over a weekend and is called the December Experience Camp. Students attend the Camp as well as the Audition Weekend, and the staff works closely with them on a variety of drum corps related skills. The capstone performance is now at the end of the Audition Weekend.



The Organization has also developed other educational programs, the most recent one being Snare Camp in 2009. In December 2010, Dance Theater was created, and the Organization will run a Drum Major Camp in July 2011. The Drum Major Camp is actually the senior project of Mark Kveton, Pacific Crest's Drum Major; however, it is anticipated that the program will continue into the future.

For nearly two decades we have provided educational and performance programs for youth in Southern California. The growth of Pacific Crest from a fledgling drum and bugle corps with 33 performers to a nationally respected program that serves 2,000 youth is a source of pride for our Organization.

Corps at the Crest

We hosted our first Drum Corps International Tour Event at Mt. San Antonio College in 1995. Those who attended the event will remember that it occurred on the Fourth of July as part of Mt. San Antonio College's fireworks presentation! Since then Corps at the Crest



has developed into a series of two shows -- one in San Diego and the other in Walnut, the premier Drum Corps event in Southern California. With a dozen corps in performance each year, this program provides a stage for more than 1,000 young performers from around the world!

School Group Outreach

Attending a live performance can be inspiring, but drum corps shows can prove unaffordable to many high school students. Pacific Crest offers Southern California school music programs a way to get their students to Corps at the Crest. For school groups of 50 or more, Pacific Crest makes tickets to the Walnut or San Diego show available for only \$5 per ticket. This outreach program opens an opportunity for hundreds of Southern California band and color guard students each summer to attend a live drum corps event.

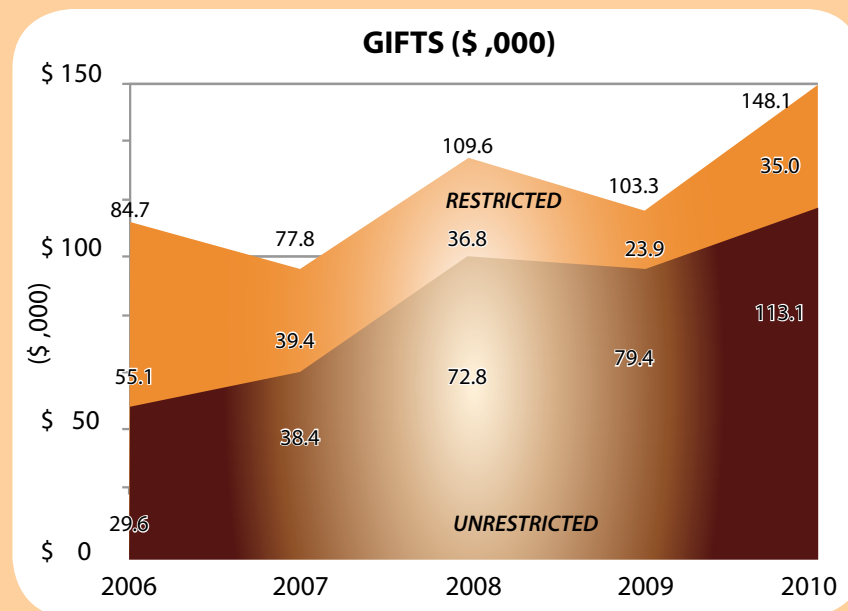
